Data entry into database ND/ICU/NH

#### **Data entry**

Similar to the previous nutritionDay process, your data entry will be via our website <u>www.nutritionday.org</u>. Click  $\rightarrow$  "my nDay | login"  $\rightarrow$  "data entry | upload" and choose your category (hospital, ICU or nursing home). Enter: your centre and unit code! e.g. centre code: 1234 Unit code: 5678

Data entry code: 1234nd5678 (exchange "nd" with "icu" or "nh" for your category) Unit code: 5678

**Reminder outcome data entry ICU and ND** 

Please complete the Evaluation questionnaire (outcome evaluation) for the designated unit type as part of the outcome data collection process. (The Evaluation questionnaire is available under "<u>30</u> <u>languages</u>"  $\rightarrow$  choose your language  $\rightarrow$  choose the "**Evaluation questionnaire**" in the right category (green/orange/brown) on the bottom of the page).

Please use the patient's medical record for your outcome data collection. You do not need to contact the patient for this information.

As usual, you can do your data entry via our homepage <u>www.nutritionday.org</u>. Click "my nutritionDay  $| \text{ login}" \rightarrow "$ data entry | upload" and choose your category. Log in with your centre and unit code (as indicated above) and complete "**sheet 2 & outcome data**" for each patient. The icon turns green when the outcome evaluation of a patient has been saved successfully.

#### Report download/ limits to receive unit reports

For report download go to "my nDay | login"  $\rightarrow$  "reports | download" choose the report of 2014 of your category". Login using your "Data entry code" and "unit code" (as indicated above). Go to the tab "**REPORT**". Follow the step by step guidance for "data entry and report download (link to the English version is indicated above) for help!

### Limits to receive report

The **nutritionDay report for hospitals** is immediately available for download from the nutritionDay website from your personal account after entering your patient's data. (minimum of 8 patients required).

A separate **nutritionDay oncology report** is immediately available for download from the nutritionDay website from your personal account after entering your patient's data. (minimum of 1 patient required).

**The final nutritionDay report for ICU** should be available from your personal account on 19<sup>th</sup> January. (minimum of 8 patients required)

**Nursing home report** is immediately available for download from the nutritionDay website from your personal account after entering your patient's data. (minimum of 8 residents required).

#### Download certificates/limits for certificate receipt

nutritionDay participants receive a certificate! To receive the nD certificate, three quality criteria have to be met:

- 1. Minimum of 8 patients/residents have to be included in the audit per unit (this is also the minimum number required to receive a unit report).
- 2. Minimum of 60% of all patients/residents present on nD have to be included in the nD audit.

3. Minimum of 80% of patients/residents (which have participated in nutritionDay) have to be included in the outcome evaluation 30 days (hospitals) or 180 days (nursing homes) after nD.
